### **Game Sites:**

- B. Host schools provide game balls and umpires
- C. Visiting Schools provide own transportation

### **Semi-Finals and Championship Game:**

- A. Semi-Finals will be played at Lenape Valley High School (Turf)
- B. Championship game will be played at Phillipsburg High School (PAC)
- C. Umpire fees will be covered by the H/W/S Athletic Association
- D. Competing schools shall provide 3 NJSIAA approved game softballs.
- E. Infield Time: both teams have twenty minutes field time each. Home team on the field first followed by the away team.

- A. Seeding determined by HWS Softball Seeding Committee on First 8 games up to and including the cut-off date. No Appeals. Seeding Committee: D. Jones, Van Orden, Mattes, Miller, Hashway
- B. Refer to Tournament Bracket for site locations.
- C. Refer to the Tournament Championship Dates Sheet located on the AD's/Coaches webpage for dates and deadlines.
- D. If a conflict exists on a schedule date, and an agreement cannot be reached on a make-up date, then the schedule date will stand.
- E. All games must be completed before the scheduled next round. Failure to comply with the deadline dates will result in forfeiture.
